Chairperson's Report June 2022 to June 2023

Our collective vision is to strengthen and capacitate human resources in Early Childhood Development.

NECDA strives to strengthen and support Early Childhood Development (ECD) Resource and Training Organisations to build a better future for our children, families, and communities, through skills development and capacity building, forming strategic alliances and partnerships, as well as advocating and lobbying for ECD.

Strategic Goal 1 is focused on lobbying and advocacy, partnerships, and government liaison. NECDA is represented by NECDA board members in both the ECD Intersectoral Committee and the HRDP Task Team where issues related to training and resourcing in ECD are highlighted and conversations influenced. NECDA undertook four projects successfully implemented by NECDA members and funded by NECT and UNICEF. Members of the board attended the African ECD Networks Conference in Lusaka, Zambia creating opportunities to engage with ECD networks across SADEC.

Strategic Goal 2 is information sharing. The primary achievement under this goal is the redesign of the newsletter format and the publication of two newsletters. The website is updated when required and the need to engage a communications company to manage NECDA's social media is being considered.

Strategic Goal 3 is focused on skills development and building the capacity of NECDA members. NECDA proudly launched the Occupational Certificate: Early Childhood Development Practitioner, SAQA ID: 97542 qualification and the Self-care Guide for ECD practitioners. Train-thetrainer workshops were held to capacitate trainers on both the courses. NECDA contributed to conceptualising the ECD Skills Survey taking place in June. Members are encouraged to participate in the survey since the results will inform future capacity building initiatives for members.

Strategic Goal 4 focused on strengthening the administrative and co-ordination functions for NECDA. A Membership Management System

was developed and will be deployed in the next month. In addition, all governing policies NECDA board were reviewed. The role and job description of the CEO was developed and seeking funding to support this role is underway.



I want to express my heartfelt thanks to every board member that served NECDA members with commitment and diligence during their tenure. Their contributions to NECDA were of immense value and we thank them for the work they did for NECDA during their tenure. Kelahloko Mashiloane, Kaathima Ebrahim, Rene King and Ruby Motaung stepped down from the board during the year under review. Five new board members were co-opted. 


NECDA EXECUTIVE OVERVIEW OF THE INCOME AND EXPENDITURE FOR THE PERIOD





As decided at the AGM, NECDA hosted an Extraordinary General meeting on 3rd August 2022. 23 member organisations and 29 participants were present. Tracey Fortune, the Director of ELRU, together with technical support from Redefine Software facilitated a professional and successful EGM. NECDA Projects 2022/23

KwaZulu-Natal ECD Relief Project

NECDA was contracted by the National Education Collaboration Trust (NECTA) and UNICEF to contribute to the emergency response to the 2021 riots and later flooding in KwaZulu Natal. Funding was provided by the LEGO Foundation.

Seven NECDA members were selected to provide training and support in twelve Districts in KZN. These were Cotlands, ELET, LETCEE, Lulamaphiko, Midlands Community College, New Beginnings, and TREE. The project was led by TREE on behalf of NECDA. Three NECDA members, ITEC, Motheo Training Institute Trust, and Ububele Educational and Psychotherapy Trust were appointed to develop curriculum and materials. Additional support/materials were provided by the Do More Foundation and Book Dash.

Trainers from the seven NECDA agencies attended a workshop at TREE in May 2022, where they were trained on the following:

- The use of **Repurpose for Purpose** materials to help develop young children's problem-solving, matching, sorting, organising, sharing and concentration skill.
- '5 Steps to Self-Care', a programme to help ECD Practitioners manage stress and promote their own well-being.
- 'Play at Home': helping caregivers to use children's books to read and play with their children at home.

Despite very tight timeframes, the targets were exceeded, as follows:

UNICEF Water, Sanitation, and Hygiene (WASH) ECD Programme

NECDA partnered with World Vision and UNICEF to implement a Water, Sanitation and Hygiene (WASH) programme in 50 ECD communities. The purpose of the programme was to **improve handwashing**, **hygiene**, **and nurturing care practices** in 50 ECD communities in the Eastern Cape and Free State through 12 local community-based organisations.

NECDA was responsible for

- the rapid assessment of handwashing, hygiene and nurturing care practices in 50 ECD centres
- the **rapid assessment of capacity** in 12 implementing CBOs
- developing a training programme and materials, and
- conducting and monitoring the training.

Puleng Motsoeneng of Ntataise coordinated the project in the Free State, and Caroll Warmberg of ITEC coordinated the project in the Eastern Cape. In addition, ITEC was tasked with developing and analysing rapid assessments of CBOs and ECD Centres prior to implementation and developing the programme and materials for both CBOs and ECD practitioners.

This project reached 12 CBOs, 55 ECD Centres, and 93 ECD practitioners across the two provinces.

NECDA is proud to have delivered an excellent programme, despite very tight timelines. A case study on the programme has been published on the COVID-19 Hygiene Hub, housed at the London School of Hygiene and Tropical Medicine.

Master Training: QCTO Occupational Certificate: Early Childhood Development Practitioner

Provincial training of Master Trainers on the use of the NECDA Learning Programme materials for this qualification continued throughout the period, as follows:

• Cape Town: October 2022

• Kwazulu-Natal: November 2022

• **Gauteng**: May 2023.

Twenty member organisations across six provinces have accessed the NECDA Learning Programme materials to date.

QCTO Registration: on 31 August 2023, NECDA hosted a webinar to provide information and support for RTOs that want to register as a Skills Development Provider with the QCTO.

Self-Care Capacity Building Training of Trainers

Following the successful Self-Care programme for ECD Practitioners as part of the KZN ECD Relief project, NECDA members requested the programme also be shared across the network, and a two-day virtual Training of Trainers was held on 11 and 12 May 2023. The workshop, facilitated by Pravienna Naidoo from Motheo Training Institute, was attended by approximately 44 facilitators from 30 member organisations.

We hope to host another Self-Care ToT session later in the year.

5 STEPS TO SELF-CARE



VVOB Project: the Professionalisation of ECD

Saide (South African Institute for Distance Education) is leading this project, which aims to develop:

- ECD specific Professional Teaching Standards
- A professional pathway for ECD Practitioner workforce
- Guidelines for providers on the development of ECD Training Programmes.

NECDA has appointed Rene King to participate in this very important project.

On 14 April 2023, NECDA hosted a VVOB presentation on 'The Professionalisation of the ECD Sector.'

ECD Skills Survey

Umncedi (a resource hub of the DG Murray Trust), in collaboration with NECDA, is conducting a skills survey of Resource and Training Organisations that support the early childhood development sector. The survey will update previous research, will help to identify the current scale and nature of ECD training, the needs of RTOs, and will help to inform the human resources development plan for ECD in South Africa. Survey results will be shared with the ECD sector.

Umncedi and NECDA hosted an online Skills Survey meeting with NECDA members on 1 June 2013.
